This agreement is between the dealer group of one part, and Equity Trustees Limited (EQT) of the other part, collectively known as 'the Parties'.

# Dealer group registration form

In respect of any remuneration payable to the dealer group for sales of intermediary services (the Supplies) supplied by the dealer group and its authorised representatives, the Parties agree that:

- EQT can issue tax invoices in respect of the Supplies, and
- the dealer group will not issue tax invoices in respect of the Supplies.

The Parties make the following representations and provide the following warranties as a consequence of entering into this agreement:

- the dealer group acknowledges that it registered for GST at the time of entering into this agreement and that it will notify EQT if it ceases to be registered
- EQT acknowledges that it is registered at the time of entering into this agreement and that it will notify the dealer group if it ceases to be registered or if it ceases to satisfy any of the requirements to issue RCTIs, and
- the dealer group undertakes to inform EQT if it ceases to comply with any of the requirements or undertakings provided in this agreement, or of any other issue known to, or on becoming known by the dealer group, which would cause the dealer group to not qualify for EQT to issue RCTIs to it.
